**What this Privacy Policy Covers:**

This privacy policy covers NissTec Lifts treatment of personally identifiable information collected by NissTec Lifts from customer's (hereafter "customer" or "you(r)") who purchase our products.

This privacy policy does not apply to the practices of companies that NissTec Lifts does not own or control, or of persons that NissTec Lifts does not employ or manage, including any third-party content contributors bound by contract and any third-party websites to which NissTec Lifts' website links.

**Collection and Use of Personal Information:**

You can visit the NissTec Lifts website without revealing any personal information. However, NissTec Lifts needs certain personal information if you wish to purchase our products.

When you purchase products from NissTec Lifts, we ask for your contact information (such as your name, street address and e-mail address), as well as certain billing information, such as your credit card number. NissTec Lifts will use this information to reply to your inquiries, to provide you with requested products, to set up your account, and to contact you regarding new products and services.

In the course of processing a payment transaction, we typically receive information related to the transaction from the credit card processing institution. This normally includes confirmation of the payment and the information furnished by you when placing the order.

NissTec Lifts does not offer services or sell products to children. NissTec Lifts does not request or knowingly collect personally identifiable contact information from anyone under the age of 13.

By accessing the services of NissTec Lifts and voluntarily providing us with the requested personal information, you consent to the collection and use of the information in accordance with this privacy policy.

**Information Sharing and Disclosure**

Protecting personally identifiable information about our customers is an important part of our business. We share and disclose such information only as described below.

NissTec Lifts will send personally identifiable information about you to other companies or people when:

1. We have your consent to share the information
2. We need to share your information to provide the product you have requested

3. We need to send the information to companies who work on behalf of NissTec Lifts to provide a product or service to you. Unless we tell you differently, these companies do not have any right to use the personally identifiable information we provide them beyond what is necessary to assist us.

Personally identifiable consumer information is shared with third parties (such as banks and credit card processors) to the extent necessary for NissTec Lifts to deliver payment processing information.

We also may release personally identifiable information when we believe release is appropriate to comply with law or protect the rights, property, or safety of NissTec Lifts, our customers, or others. This includes exchanging information with other companies and organizations for fraud protection and risk reduction.

**Consent:**

If you do not consent to the collection, use or disclosure of your personal information as outlined in this policy, please do not provide any personal information to NissTec Lifts.

**Security:**

Unfortunately, no data transmission over the Internet can be considered 100% secure. However, your NissTec Lifts Information protected for your privacy and security. In certain areas of our websites, as identified on the site, NissTec Lifts uses industry-standard SSL-encryption to protect data transmissions.

We also safeguard your personal information from unauthorized access, through access control procedures, network firewalls and physical security measures.

Further, NissTec Lifts retains your personal information only as long as necessary to fulfill the purposes identified above or as required by law.
